## How will my application be assessed?

The decision to extend the operational period of a development authorisation requires assessment against a number of factors. These include:

- The reasons for the delay in completing the development;
- The extent to which the development has been commenced;
- The extent of work remaining to complete the development;
- The length of the delay (*please state length of time requested*);
- Material changes to the law or Council's Development Plan since consent was granted;
- Material changes in the circumstances of the locality;
- Prejudice to the applicant or the community in granting an extension; and
- The applicant's diligence in pursuing the extension.

Please note, in assessing an extension of a development authorisation, Council is not required to reconsider the merits of the original proposal.

## How long will it take to assess my application?

Processing time will depend on the nature and complexity of the proposal and may also be affected by the information you provide in support of your application.

If additional information is required to make a thorough assessment of your application, Council will notify you and will put your application on hold until the information is received.

## How much will it cost?

For the 2018/2019 financial year, the fee to process an application to extend a development authorisation is \$102.00. Your application will be processed when the required fee has been paid.
