- 9.1 At the September Council meeting Cr Kerley asked the following questions, and answers are provided below. Cr Kerley requested that more detailed answers be provided to these questions at the next Council meeting.
 - 1. What was the nature of the work undertaken by Al Megson in the Port Broughton Community Hall kitchen, and elsewhere in the Hall?

 Al Megson is currently out of the country.. The Acting CEO advised that it is understood that Al Megson was asked to attend to repairs of the hall ceiling, which was leaking after a rain event, and some other maintenance in the hall and kitchen area.
 - 2. What was the cost of the work undertaken?

 The Acting CEO advised that we have no record of payment on our financial system.
 - 3. Why was it necessary to have work undertaken in a new kitchen just recently completed and at whose expense?

 The Acting CEO advised that it is understood that there was some form of maintenance work undertaken in the kitchen, but we are not sure of the precise nature.

 - 1. Under Occupational Health & Safety regulations is it a requirement to have a hand basin in a kitchen for hand washing prior to the preparation of food in a public venue?
